Market Summary

- In the first 10 months of 2024, there were 331,313 visitors from Canada, compared to 366,590 visitors (-9.6%) in the first 10 months of 2023 and 425,324 visitors (-22.1%) in the first 10 months of 2019. Visitors from Canada spent \$806.5 million in the first 10 months of 2024, compared to \$935.4 million (-13.8%) in the first 10 months of 2023 and \$853.6 million (-5.5%) in the first 10 months of 2019. Daily visitor spending in the first 10 months of 2024 (\$223 per person) was higher compared to the first 10 months of 2023 (\$218 per person, +2.0%) and the first 10 months of 2019 (\$166 per person, +34.2%)
- In the first 10 months of 2024, 1,765 scheduled flights with 317,454 seats serviced Hawai'i from Canada. In the first 10 months of 2023, there were 1,957 scheduled flights (-9.8%) with 354,408 seats (-10.4%). In the first 10 months of 2019 there were 2,010 scheduled flights (-12.2%) with 378,268 seats (-16.1%).
- In 2023, there were 474,727 visitors from Canada, compared to 414,250 visitors (+14.6%) in 2022 and 540,103 visitors (-12.1%) in 2019.
- Visitors from Canada spent \$1.23 billion in 2023, compared to \$962.1 million (+27.9%) in 2022 and \$1.08 billion (+13.8%) in 2019. Daily visitor spending in 2023 increased to \$220 per person, from \$190 per person (+16.1%) in 2022 and \$165 per person (+33.5%) in 2019.
- In of 2023, there were 2,566 scheduled flights with 466,196 seats from Canada, compared to 2,473 flights (+3.8%) with 487,215 seats (-4.3%) in 2022 and 2,545 flights (+0.8%) with 484,613 seats (-3.8%) in 2019.

Market Conditions

- Economists described Canada's economy as being in a holding pattern in October 2024, as business decision makers waited for the results of the U.S. election due to how the election could affect future policies that can impact trade and the economy.
- The exchange rate from CAD to USD worsened considerably in October 2024, which has caught the attention of consumers and media. October began with 1 CAD worth \$0.74 USD, and ended with 1 CAD being worth \$0.71 USD. Economists attribute this drop to uncertainty related to the outcome of the US election.
- The unemployment rate held at 6.5 percent in October 2024, which is not seen as a positive result. Economists tend to see the ongoing interest rate reductions by the Bank of Canada as fuel for future economic growth which will reduce the unemployment rate.
- More than 23 million Canadians returned home from an overnight outbound trip throughout Jan-Aug 2024. This was 10.2 percent more activity than last year and a similar volume of trips as recorded in 2019 (-0.6%). The volume of transborder trips year-to-date is 2 percent lower than in 2023 but slightly above 2019 activity (+0.6%), while overseas activity remains at 98 percent of 2019 volume.
- US Transborder Travel - More than 14.1 million Canadians returned home from an overnight transborder trip between Jan-Aug 2024, a lower level of activity than last year (-2.2%) but a similar volume as recorded in 2019 (+0.6%). Trips by air reached 6.6 million during the period, a larger volume than reported in 2019 (+16.3%) but a 10.8 percent drop over last year. On the other hand, trips by auto remain below the level seen in 2019 (-8.8%) but are up 6.6 percent compared to last year.

- Canadian International Travel
 - Almost 4.98 million Canadian arrivals were recorded in Europe and the UK throughout the first eight months of 2024, a larger volume than reported in both 2019 (+12.7%) and 2023 (14.1%).
 - Nearly 1.97 million Canadian arrivals were recorded in the Asia-Pacific region throughout the first eight months of 2024; 85 percent of the volume seen in 2019 and 28.5 percent more activity than recorded last year.
 - Caribbean and Latin America reported 4.18 million arrivals from Canada throughout the first eight months of 2024, a larger volume than seen in 2019 (+2.1%) and an 8.3 percent increase over last year.
